Processing Guidelines

SCGC HDPE H377C is recommended to blend with general cast/coating PE resin to enhance processability or use 100% with co-extrusion cast/lamination machine. Generally, melt temperature should be around 220-240°C and 310-330°C for casting and extrusion lamination, respectively.
